- Interim and final reports will be required.
- Payments for services of La Crosse School District employees are prohibited.

Criteria

Applications will be reviewed on a competitive basis by the Grants Committee of the La Crosse Public Education Foundation. Priority is given for Classroom Innovation Grants that:

- meet multiple educational objectives
- align with district/school/curricular goals
- impact a variety of students and/or schools
- are collaborative
- are sustainable

Please see the Classroom Innovation Grant evaluation rubric for the grant proposal evaluation criteria. Although most applications are worthy of awarding, the committee has limited funding and must set priorities that help the foundation fulfill its mission.

Section 3: Project Description:

In the 21st Century, one of the most important elements of student learning is "engagement" or buyin of student learning. This engagement can come in all forms, but for some students the four walls of the bricks and mortar building just do not seem to provide this internal motivation or desire for students to want to learn to the best of their ability. For these students, alternative methods of engagement or motivation appear to provide the "key" to building internal motivation. The bottom line is that it is imperative to reengage these students in their learning, as these are the students at highest risk for dropping out of school. Community service learning appears to have a positive impact on these learners and is a way that makes their learning come alive. Students get an opportunity to give back to their community in a way that holds meaning for them. Whether it is walking dogs, cleaning out pens, learning about the facility, stuffing dog and cat treats or sweeping floors, the Coulee Region Humane Society is an area that is truly a collaborative way for these students to learn.

In order to provide this experience by March of 2011, ten 8th grade "at-risk" students from Longfellow Middle School will become students of the Coulee Region Humane Society resulting in a

large service-learning project that will benefit both the students and the Coulee Region Humane Society. This project will be complete and presented to The Coulee Region Humane Society no later than June 3, 2011.

The number of students that this program would affect would be ten, 8th grade "at-risk" students. The number is low due to the fact that this population is identified after many other interventions have been tried and have found to be unsuccessful. We believe that reaching this population is well worth our time and efforts, as we believe that these students will become adults who live in our community. To give them every reason to want to learn is the best thing we can do for them.

VI. Please state how you will collaborate with...

This project is not possible without our partnership with the Coulee Region Humane Society. These people have committed to meeting with and teaching our students once a week for ten weeks. These people introduce our students to the totality of what the agency does (by teaching short lessons each week) and then they invite them to be a part of CRHS in terms of doing for our community animals.
