Guidelines

- The grant may be denied if another funding source might be more appropriate.
- Project funds must be spent by May of 2012.
- Interim and final reports will be required.
- Payments for services of La Crosse School District employees are prohibited.

<u>Criteria</u>

Applications will be reviewed on a competitive basis by the Grants Committee of the La Crosse Public Education Foundation. Priority is given for Classroom Innovation Grants that:

- meet multiple educational objectives
- align with district/school/curricular goals
- impact a variety of students and/or schools
- are collaborative
- are sustainable

Please see the Classroom Innovation Grant evaluation rubric for the grant proposal evaluation criteria. Although most applications are worthy of awarding, the committee has limited funding and must set priorities that help the foundation fulfill its mission.

Section 3: Project Description:

I. By May 15th, 2011, students will participate in a performing arts club, resulting in students demonstrating an understanding of the visual, theatrical, and musical fine arts by participating in a musical about the environment. Students will design and create their own costumes, sets, and props. Students will learn speaking parts and act as specific characters. Students will sing individually and as part of a chorus. Students will understand issues affecting the environment and learn ways they can help the situation. Students will gain confidence and be able to perform, sing, and speak in front of an audience. Students will utilize writing and graphic design skills by creating programs and posters. Club

members will also be videotaping and uploading the production which will build upon technology skills.

We plan to offer our club for one semester initially but would like to offer to perform the musical for classrooms, other schools, and community organizations. Since we will own the materials needed to put on the musical, it can be performed in the future.

V. Approximately how many students will be affected by this project? Explain your number.

At least 500 students will be affected by this project. 30 - 40 students will be involved in creating the production. We will perform it for Franklin, Roosevelt and Coulee Montessori student bodies. We will also offer to perform it for other schools around the district which would increase the number of students affected.

We would like to perform the musical for area nursing homes and community centers.

We would love to perform our musical for other schools in the district. This would a free option for schools with limited budgets to pay for assemblies and special performances. Teachers could also borrow the music, set, and costumes when we are finished.

We will welcome volunteers from the Logan High School art and music department to help in our production. We also have an AmeriCorps worker, Zoe Fay, who has offered to be an assistant for the club.

VII. What will happen to the project at the conclusion of the grant? If it is to continue, how will it be sustained? At the conclusion of the grant we will have the music and set if other schools would like to produce the same show. Once we have created the set, costumes, and props and purchased the music, we can perform it at any time in the future. We currently do not have a budget for our club and need only the upstart costs to be covered.

VIII. How could the project be shared with other teachers and schools to benefit more students? We would like to bring our production to other schools to be performed. Once we are finished with the musical all of our products including the music can be borrowed to district schools. We would also like to perform for other buildings. The musical has a very educational and easy to understand message about protecting the environment. Since budgets are so reduced, our performance would be a free alternative to costly assemblies or productions for other buildings. Our fifth grade teacher, Debra Keller, offered to help students videotape the performance. This can be shared in a variety of ways online which would benefit not only La Crosse School District students but students all over the world.
